

Safeguarding and Welfare Requirement: Safety and Suitability of Premises, Environment and Equipment

Providers must take reasonable steps to ensure the safety of children, staff and others on the premises.

Health

The provider must promote the good health of children attending the setting.

8.1 Health and safety general standards

Policy statement

We believe that the health and safety of children is of paramount importance. We make our setting a safe and healthy place for children, parents, staff and volunteers.

- We aim to make children, parents, staff and volunteers aware of health and safety issues and to minimise the hazards and risks to enable the children to thrive in a healthy and safe environment.
- Our member of staff responsible for health and safety is:

Procedures

Awareness raising

- Our induction training for staff and volunteers includes a clear explanation of health and safety issues, so that all adults are able to adhere to our policy and procedures as they understand their shared responsibility for health and safety. The induction training covers matters of employee well-being, including safe lifting and the storage of potentially dangerous substances.
- We keep records of these induction training sessions and new staff and volunteers are asked to sign the records to confirm that they have taken part.
- We explain health and safety issues to the parents of new children, so that they understand the part played by these issues in the daily life of the setting.

- As necessary, health and safety training is included in the annual training plans of staff, and health and safety is discussed regularly at our staff meetings.
- We operate a no-smoking policy.
- We make children aware of health and safety issues through discussions, planned activities and routines.

Windows

- Low level windows are made from materials that prevent accidental breakage or we ensure that they are made safe.

Doors

- We take precautions to prevent children's fingers from being trapped in doors. Door guards are placed on the hinges of both entrance doors to stop trapped fingers, however care should still be taken when closing doors.
- The outside door should be propped open carefully and securely so that there is no danger of it closing accidentally.
- Fire/Entry/Exit doors are never obstructed.
- Exit doors are kept locked during sessions. The kitchen 'stable' door is kept bolted at all times when children are present.

Floors and walkways

- All our floor surfaces are checked daily to ensure they are clean and not uneven, wet or damaged. Any wet spills are mopped up immediately.
- Walkways are left clear and uncluttered.

Electrical/gas equipment

- We ensure that all electrical/gas equipment conforms to safety requirements and is checked regularly.
- Our boiler/electrical switch gear/meter cupboard is not accessible to the children.
- Fires, heaters, electric sockets, wires and leads are properly guarded and we teach the children not to touch them.
- We check storage heaters daily to make sure they are not covered. Wet clothes should not be draped over them.
- There are sufficient sockets in our setting to prevent overloading.
- We switch electrical devices off from the plug after use.
- We ensure that the temperature of hot water is controlled to prevent scalds.
- Water temperature is checked monthly re Legionella bacteria.
- Lighting and ventilation is adequate in all areas of our setting, including storage areas.
- A smoke alarm is fitted and is checked weekly.
- No smoking is allowed on pre-school premises - indoors or outside.
- A correctly stocked First Aid Box is available at all times.

Storage

- All our resources and materials, which are used by the children, are stored safely.
- All our equipment and resources are stored or stacked safely to prevent them accidentally falling or collapsing.
- All dangerous materials, including medicines and cleaning materials are stored safely out of the reach of children.

Outdoor area

- Our outdoor area is securely fenced. All gates and fences are childproof and safe. Gates are kept padlocked whilst children are out at play.
- Our outdoor area is checked for safety and cleared of rubbish, animal droppings and any other unsafe items before it is used.
- Adults and children are alerted to the dangers of poisonous plants, herbicides and pesticides. Plants are checked and only those considered safe, non-hazardous and non-poisonous are planted.
- We leave receptacles upturned to prevent collection of rainwater. Where water can form a pool on equipment, it is emptied and cleaned before children start playing outside.
- Our outdoor sand pit is covered when not in use and is cleaned regularly. Only children's 'play sand' (or silver sand) is used. Children are encouraged to play carefully with the sand and help to clean up any spillages to avoid accidents. Staff ensure that the floor/path is swept regularly.
- We check that children are suitably attired for the weather conditions and type of outdoor activities; ensuring that sunscreen is applied and hats are worn during the summer months.
- We supervise outdoor activities at all times; and particular children on climbing equipment. Any climbing equipment should be used on our soft play area which is suitable for climbing equipment up to 120cm.
- Only authorised visitors are allowed access and are escorted by staff to/from the entrances/exits during their visit.
- The member of staff supervising outdoor play carries the padlock code and a whistle at all times.
- Access to the school's playground, garden and pond and village playing field is also available depending on appropriate adult: child ratios and the completion of a satisfactory risk assessment.
- The committee organises a group of volunteers to clean and maintain the building and outdoor/garden at least twice a year.

Indoor Area

The premises and equipment are organised in a way that meets the needs of children.

We meet the following indoor space requirements based on the net or useable areas of the rooms used by the children, not including storage areas, thoroughfares, dedicated staff areas, cloakrooms, utility rooms, kitchens and toilets:

- Children under two years: 3.5 m² per child
- Two year olds: 2.5 m² per child
- Children aged three to five years: 2.3 m² per child

Hygiene

- We seek information from the Public Health England to ensure that we keep up-to-date with the latest recommendations.
- Our daily routines and curriculum topics encourage the children to learn about personal hygiene. The following good practices are observed:
 - Hands are washed after using the toilet, prior to snack/lunch time and prior to participating in cookery activities and/or handling food.
 - Tissues are available and children are encouraged to blow and wipe their noses when necessary. Soiled tissues are disposed of hygienically in the bin and the children encouraged to wash their hands.
 - Children are encouraged to 'catch their cough' - shielding their mouths when coughing and/or sneezing.
 - Posters on 'hand washing' and 'coughs and sneezes' are prominently displayed. Further copies can be obtained from the Department of Health dh@prolog.uk.com
- We have a daily cleaning routine for the setting, which includes the play room(s), kitchen, rest area, toilets and nappy changing areas. Children do not have unsupervised access to the kitchen.
- We have a schedule for cleaning resources and equipment, dressing-up clothes and furnishings.
- The toilet area has a high standard of hygiene, including hand washing and drying facilities and disposal facilities for nappies.
- We implement good hygiene practices by:
 - cleaning tables between activities;
 - cleaning and checking toilets regularly;
 - wearing protective items - such as disposable gloves - as appropriate;
 - providing sets of clean clothes;
 - providing tissues and wipes

Activities, resources and repairs

- Before purchase or loan, we check equipment and resources to ensure that they are safe for the ages and stages of the children currently attending the setting.
- We keep a full inventory of all items in the setting for audit and insurance purposes.
- The layout of our play equipment allows adults and children to move safely and freely between activities.
- All our equipment is regularly checked for cleanliness and safety, and any dangerous items are repaired or discarded.
- We make safe and separate from general use any areas that are unsafe because of repair is needed.
- All our materials, including paint and glue, are non-toxic.
- We ensure that sand is clean and suitable for children's play.
- Physical play and activities such as water play, cooking and woodwork are constantly supervised.
- We teach children to handle and store tools safely.
- We check children who are sleeping at regular intervals of at least every ten minutes. This is recorded with the times checked and the initials of the person undertaking the check.
- If children fall asleep in-situ, it may be necessary to move or wake them to make sure they are comfortable.
- Children learn about health, safety and personal hygiene through the activities we provide and the routines we follow.

- Any faulty equipment is removed from use and is repaired. If it cannot be repaired it is discarded. Large pieces of equipment are discarded only with the consent of the supervisor and the management team.
- Adults should not walk about with hot drinks or place hot drinks within reach of children, they must also be in a cup with a lid.
- When visiting other areas, staff will check and make sure children do not use faulty equipment. Any faults should be reported to the owner or relevant organisation at the earliest opportunity.

Jewellery and accessories

- Our staff do not wear jewellery or fashion accessories, such as belts or high heels, that may pose a danger to themselves or children.
- Parents must ensure that any jewellery worn by children poses no danger; particularly earrings which may get pulled - We ask that any child with pierced ears either has their earrings removed by their parents/carers prior to the session or wears tape over their earrings (to be carried out by their parents/carers prior to the session) these earrings must be studs only. We do not permit bracelets which can get caught when climbing or necklaces as they may pose a risk of strangulation.
- We ensure that hair accessories except hairties are removed before children sleep or rest.

Safety of adults

- We ensure that adults are provided with guidance about the safe storage, movement, lifting and erection of large pieces of equipment.
- We provide safe equipment for adults to use when they need to reach up to store equipment or to change light bulbs.
- We ensure that all warning signs are clear and in appropriate languages.
- We ensure that adults do not remain in the building on their own.
- We record the sickness of staff and their involvement in accidents. The records are reviewed termly to identify any issues that need to be addressed.

Control of substances hazardous to health

- Our staff implement the current guidelines of the *Control of Substances Hazardous to Health Regulations (COSHH)*.
- We keep a record of all substances that may be hazardous to health - such as cleaning chemicals, or gardening chemicals if used and where they are stored.
- Hazardous substances are stored safely away from the children.
- We carry out a risk assessment for all chemicals used in the setting. This states what the risks are and what to do if they have contact with eyes or skin or are ingested.
- We keep all cleaning chemicals in their original containers.
- We keep the chemicals used in the setting to the minimum in order to ensure health and hygiene is maintained. We do not use:
 - bleach;
 - anti-bacterial soap/hand wash, unless specifically advised during an infection outbreak such as Pandemic flu; or

- anti-bacterial cleaning agents, except in the toilets, nappy changing area and food preparation areas. Anti-bacterial spays are not used when children are nearby.

- Environmental factors are taken into account when purchasing, using and disposing of chemicals.
- All members of staff are vigilant and use chemicals safely.
- Members of staff wear protective gloves when using cleaning chemicals.
